Review of Manatee Mortality




The proportion of manatee mortality caused by boats is twice as high in counties with FWC speed zones compared to counties without FWC speed zones.

Mortality rate (the percent of manatees killed by boat strikes) is lower in counties without Manatee Protection Plans (MPPs), or without Fish & Wildlife Commission (FWC) speed zones.

There is a distinct difference between counties with "protection" and those without FWC protection (either MPPs or speed zones). FWC speed zones are also seeing watercraft mortality rates decline – while the rate is staying steady in counties with speed zones.

In the charts below, the vertical axis shows the percent (%) of total mortality caused by watercraft for three time periods: 1976-2000 (predating most speed zones and MPPs); 2001-2010 (implementation of zones and plans); and 2006-10, the most recent five-year period for which data is available. The mortality rate is generated by dividing watercraft mortality by total mortality.

Deaths Excluded From Total Deaths


Interestingly, much of the decline in mortality rates is likely due to a dramatic increase in cold stress deaths, a relatively recent phenomenon.

Cold stress deaths have risen from 4% of total mortality from 1976-2000 to 15% in 2006-10.

Because cold stress deaths are now a bigger piece of the whole pie, they reduce the size of the other pieces. When the data are corrected by removing cold stress deaths, a more accurate picture emerges, showing less of a reduction in watercraft mortality rates.

These findings are startling for two reasons.

DEP's Clean Marina Program Reaches 250th Designation by DEP Press Office (Continued from Page 1)

Clean Marina is an accomplishment this facility should be proud of, and we're excited to welcome it to our growing Clean Marina family."

The Clean Marina program recognizes marinas and boatyards for their commitment to the protection of Florida's waterways and natural resources. In addition to Clean Marinas, the program consists of 37 Clean Boatyards and 16 Clean Retailers as of Jan. 10, 2012.

The Sarasota Yacht Club demonstrated a commitment to environmental stewardship by starting a recycling program, offering pumpout service and adding a pet sanitation area with signage and waste collection bags.

Also, the Club installed a trench drain at its boat ramp, which captures runoff water from boats before it enters the water body. Manatee signs and hurricane preparation have been added to the lease agreement. The marina continues to educate staff on clean marina safety.

"The Sarasota Yacht Club takes an active role in protecting Florida's natural resources by hosting annual fundraisers to support oyster reef restoration projects in Sarasota Bay," said DEP Southwest District Director Gary Colecchio.

There are seven steps to designation, which a verified in a confirmation visit from team of Florida Clean Marina Program and Clean Boating Partnership representatives once criteria have been met. A DEP representative also visits the facility to verify the marina's Action Plan.

"We are pleased to receive this important certification," said Bernhard G. Kloppenburg, the general manager of Sarasota Yacht Club. "Our members share our interest in engaging in environmentally sound practices and we all recognize the role we play in protecting Florida's waterways."

Other designated marinas in Sarasota County include: Crow's Nest Marina, Gulf Harbor Marina, Hyatt Regency Sarasota Marina, Marina Jack and Venice Yacht Club. Established in 2000, the Florida Clean Marina Program is a voluntary, non-regulatory designation program that acknowledges and rewards environmentally conscious marine facilities. ❖

Review of Manatee Mortality

First is that proponents of speed zones have long argued that, without zones, the proportion of manatee mortality caused by boats would be rising, as there are more boats on the water (or at least registered) today than in the past, thereby increasing the risk of a manatee being struck by a boat.

The numbers say exactly the opposite. In counties without speed zones, the rate of watercraft mortality is dropping, not increasing.

The second observation is surprising: no one has examined the available data in this manner before. As has often been the case, current science about manatees originated not with regulatory agencies, but with boaters:

- Manatee acoustics (how well they hear boats), conducted by Dr Ed Gerstein and funded in part by Citizens For Florida's Waterways
- Forensic pathology (analyzing propeller marks to determine the size of a striking vessel), by James Wood, funded in part by Citizens For Florida's Waterways
- Correlating manatee abundance to visual surveys and modeling, by Tom Fraser, funded by Coastal Conservation Association, and by Tom McGill, supported by Citizens For Florida's Waterways

After years of struggle to have his work recognized, Dr Gerstein finally received permission from the US Fish & Wildlife Service to test the alarm he created that warns manatees of approaching boats.

FWC once flatly rejected Woods' premise, but a version of his method is now used by FWC's pathology lab, and revealed (as many had suspected) that large vessels traveling at slow speed are responsible for many manatee boat deaths.

Manatee abundance modeling has been heavily revised, and now shows that manatee population is growing throughout in Florida.

Next steps: There is a clear need to finally determine whether or not speed zones work – and if they do, in what configuration.


