Ethanol Alert

Speaking of CFFW eMail, I hope all of you have responded to one or more request for input from the boating community with respect to the potential switch from 10% to 15% ethanol content in most gasoline products available to consumers.

Read your engine manual and you will see that your engine and most likely your fuel system in general were not designed or manufactured to be compatible with E85 (15% ethanol) fuels and your hardware is at significant risk if it is introduced.

First and foremost, we urge each of you to take a few minutes to register your objection to the move to E85. In addition, in the event that E85 replaces the current 10% ethanol at the pump fuels, we urge you to pay special attention to all fuels introduced into your boats. After researching your hardware manuals, you may find that you should be using ethanol-FREE fuels. Manatee Forum

The Manatee Forum held its annual spring meeting in Tallahassee this May. Honestly, our government services continue to disappoint on several fronts. Their focus continues to be on increasing regulation. Western Pinellas County (Tarpon Springs to Tampa Bay) is the latest victim of new and devastating regulation on recreational boating. All based on the premise that the new restrictions MIGHT save as many as 3 manatees per year – but as we have seen throughout Florida – they will probably not reduce or eliminate the mortality – but – will eliminate boating in those areas.

CFFW is committed to restoring reasonable recreational boating access to all waterfront residents of Brevard and throughout Florida and we continue to pursue those changes. On a positive note, for those of us who enjoy frequent boating trips to the Keys, FWC has stated that there is no manatee regulatory action planned for Monroe County.

More critical focus areas for the services seem to not be getting adequate attention. These include the critical issue of carrying capacity and optimum sustainable populations and dealing with man-made warm water outflows. This is an especially important issue with respect to both the health of the IRL and the future of the warm water outflow from the FPL plant in Port St. John. More than 1/3 of all the manatees counted on the east coast this winter were huddled at the FPL sight. Because of natural water temperatures, Manatees do not belong in Brevard in the winter. This man-made influence has altered the habits of the animal and the result is an ever-increasing year-round population and added pressure on the fragile sea grass based ecosystem.

The USFWS initiated a 12-month reclassification assessment on September 1, 2014. They reported they have made little to no progress toward resolution in this assessment as of the forum meeting. So the first 9 months of the assessment period have accomplished nothing? But, what's worse, is they also said they do not have budget allocated to implement reclassification – if that is the determination. Unbelievable. We had hoped that we would get some indication of their findings to date at the meeting or even later in June at the Marine Mammal Commission meeting in June. I guess we'll have to wait and see what they publish this September.



Some of the best manatee research has always been done by the U.S. Geological Service Next on deck for the USGS is an assessment of speed zone effectiveness. This will be the first effectiveness assessment with the potential for unbiased results. All previous attempts to establish effectiveness had been lead by the same people who are responsible for establishing zones in the first place and therefore are extremely prejudiced and biased. developed and provided the population modeling which predicts 0% probability of extinction much to the objection of the crisis mongers. Most recently, USGS has developed and reported a new approach to population counting which refines the 'annual' synoptic counts by predicting the number of uncounted animals. ... 

The first results of this new approach are the estimation that there were 6300 animals in 2013, 20% more than the 4800 counted in early 2014.

One of the oft-cited defenses of the lack of demonstrated effectiveness of the vast areas of manatee protection regulations has been that boaters simply defy the zones and do not comply. FWC chose one of the more likely locations for non-compliance to monitor. It would be equivalent to monitoring compliance in the ridiculous open water channel slow-zone in the Indian River down at the Harbor Branch Institute near Ft. Pierce. This is probably the most non-compliant areas I have observed over the years because it makes NO SENSE from an on the water perspective. So once again, the results of this assessment, even though they established high compliance, were a bit biased by design. Boater compliance is not the reason that the collective affect of the zones throughout Florida is that they have had little to no affect.

One needs only to look at the following graph to see that Watercraft Mortality is insignificant with respect to manatee management and protection. Watercraft mortality is indicated by the tiny little dark blips along the bottom of the chart. •



Brevard County Dredging Project Information

In the central and northern regions of the Indian River Lagoon, record setting algal blooms have caused the loss of over 40,000 acres of seagrass, and the deaths of 223 manatees, 74 bottlenose dolphins, and over 300 pelicans. One major contributing factor is the extensive organic muck deposits created by decades of runoff, erosion and nutrient loading. These accumulated muck sediments contain significant "legacy" nutrients, which regularly flux into the water column, and recycle nutrients within the Indian River Lagoon system. Muck sediments also negatively impact navigation, damage seagrass beds, and can consume dissolved oxygen to create anoxic bottom conditions detrimental to lagoon organisms.

Brevard County has embarked on an aggressive restoration strategy for the lagoon to reduce excess nutrient inputs, remove the legacy load of muck, restore the filtration system (oysters, clams and wetlands) and ensure that sound research is the basis of the effort. As part of this restoration strategy, the removal of the legacy load (muck) is critical to overall success.

In 2014, the State legislature allocated \$10M to this project to accomplish both the science side of this question and also kick start the removal of the legacy load of muck in the lagoon. While there have been several tributary muck removal projects, to include the Eau Galle River project currently in permitting, little work has been done in the main stem of the lagoon or at the interface of the lagoon and the tributaries.

The primary purpose of this project focuses on "Removing the Muck" and providing sound "Research" by employing science alongside muck removal in the lagoon. Intuitively most ecologists and scientist are in agreement that removing the muck is a beneficial restoration effort, along with reducing the upland sources. However, there is very little science to document the actual ecological benefit of muck removal.

The Brevard County Muck Dredging project will remove up to 350,000 cubic yards of muck soils from sites within the Indian River Lagoon, the Banana River Lagoon and associated tributaries. This dredging project will remove up to 672 tons of total nitrogen (TN) and 144 tons of total phosphorous (TP) which are contained within the muck deposits.

Boating & Waterways Program: Derelict Vessels

If you suspect a specific vessel is abandoned or derelict please contact FWC dispatch, 1-888-404-3922 or Brevard County Sheriff's Marine Unit, 633-7130 or via email to specialops@bcso.us or the Natural Resources Management Office. Local Government Approaches to Derelict Vessel Removal (also known as the Derelict Vessel Process Flowchart) is a flowchart defining the process for identifying and removing derelict vessels. It was first published on December 18, 2006 by the University of Florida College of Law Conservation Clinic and modified by the Brevard County Natural Resources Management Office on September 13, 2007 to accommodate local differences. It was subsequently approved by the Brevard Marine Advisory Council and the link can be found on the Brevard County website under the BMAC link, www.Brevardcounty.us

Abandoned vessels of any size become a disposal problem whether on land, at dock or sunk. The ownership must be determined and this task can be time consuming:

- » 1. Stolen boats are often stripped, then dumped in isolated areas or sunk in our waterways
- » 2. Un-transferred titles—not all state title laws are the same. If the title was never transferred the original owner is still the legal owner
- » 3. Documented vessels titled by the US Coast Guard
- » 4. Foreign vessels
- » 5. Non-motorized vessels could be barges or sailing vessels without any mechanical power.

When ownership has been determined, legal custody of the vessel must be transferred to a responsible party for disposition. Some owners are willing to sign over the title, saving time and money. Many other owners will not be able to be located. Legal action will be necessary at that point.

If the vessel is to be placed at a county landfill,

it must meet their requirements. Fuel and oil tanks must be removed, engines and batteries must be removed, old paint and chemicals must be removed. Sunken vessels are the biggest problems to solve. Before they can be salvaged, any material that could degrade water quality must be removed. If grass beds are present, workers will need to take extra caution. Some vessels may be in such poor condition, they have to be cut up where they lay. After the vessel has been raised and moved, a bottom clean up is mandatory to make sure there is not any foreign material left. Abandoned vessels usually do not have any value. Any machinery this old most likely does not work. Hardware will cost more in labor to remove than it will bring in resale or scrap. Vessels with metal hulls have to be cut into small pieces before a scrap yard will buy them. Recovery is not cost effective. .
