Today at the Forum by Bob Atkins

Friday, February 18, 2011, speed zone effectiveness was the major issue at the Manatee Forum, held in Tallahassee, with a video link to St Pete. The topic is a direct result of CFFW's efforts — and boaters, CFFW is the ONLY boating organization representing YOU before the authorities.


I presented CFFW's position on the issue via a 30minute Powerpoint. At the end of it, Dawn Jennings of the US Fish & Wildlife Service expressed appreciation, and even led a round of applause. The reaction from FWC staff - the state Fish & Wildlife Conservation Commission-was more muted. No surprise, we contend that speed zone effectiveness – and the use of speed zones as the foundation of manatee protection - has never been proven, and never measured. My opening slide said, "Only an idiot would say speed zones never work. Only an idiot would say speed zones always work." Perhaps surprisingly no one truly disagreed with our position. Indeed, Kipp Frohlich of FWC's imperiled species unit said when they are presented with manatee -boat issues, their only response is to add another speed zone.

Our contention is that the lack of specific standards for implementing speed zones is why the authorities have failed to develop a system to measure effectiveness. Until we get serious about this fundamental problem and develop science-based measurements to justify proposing (or retaining) speed zones, and to evaluate their effectiveness over time, all we will see are more zones and more cost. Our further convention is that the most obvious standard to set for speed zones is that they won't be allowed in waters deeper than 4 feet – water deep enough for manatees to dive below the small recreational boats that catch all the heat for manatee-boat mortality (and don't deserve it, but that's another story).

In our Brevard petition, we proposed restoring higher speeds to marked channels, and reopening closed water sports areas. In effect, eliminate speed zones in deeper waters. Then monitor the effect of the change over time. The existing data and most current science indicate that eliminating zones from deeper

water should have no effect on mortality and may in fact help, as boaters would absolutely make use of higher speed channels and water sports areas. And, it would be safer for boaters, too. BUT - despite working with FWC for five years on our proposal to use Brevard County to evaluate changes in zones, FWC still doesn't have a schedule to review rules in place in Brevard. Worse, FWC promised the Brevard County Commission that it would review the Brevard MPP (manatee protection plan) five years after it was approved (a polite way of saying it was stuffed down the County Commission's throats with threats of denied permits of they balked). That was in 2002. It still hasn't been reviewed, or scheduled! CFFW even presented a County Commission resolution, unanimously approved, and even reviewed by the manatee club before the vote, urging FWC to act on our petition. Still nothing. Clearly, the squeaky wheel is not getting enough grease.

At one point, Frohlich sort of wagged a finger at me for claiming water sports areas were closed. He said hundreds of boats, park and 'picnic' at Ski Island on a typical weekend. That's still recreation, he opined, and said we "need to stick to facts" and not over-inflate claims. My partner Peggy Mathews nailed him. "Kipp, you closed 100% of the water-skiing areas in Brevard. You want statistics: that's a fact and you know it."

Did you know that in 1965 when the Port Canaveral Locks opened there were 81 towboats, 113 barges, 1470 boats with 5992 passengers aboard for total Lockages. Today there are hundreds of towboats & barges, commercial fishing vessels and tour boats that lock through, with an approximate 1200 lockage's per month.

Introduction and History of CFFW

Since 1994, Citizens For Florida's Waterways has been campaigning on behalf of boaters in Brevard County. We

attend every hearing and workshop, send representatives to Tallahassee,

meet with boating interests in other parts of Florida, and work to organize Florida's first statewide boating coalition, Standing Watch. We've written letters and columns in the Florida Today and Boat US magazine, have been interviewed for dozens of articles in several newspapers, and have been interviewed on-camera by several television news stations.

When we introduce ourselves to someone new, they usually ask something along the line of "are you for boaters or manatees?" It's a reasonable question because of the way the issue is commonly framed in the press, but the answer is simple: Citizens For Florida's Waterways exists to promote a reasonable coexistence between man and the marine environment. We work to preserve the environment in a way that will allow us to enjoy it while assuring that our children and grandchildren will be able to enjoy it in the future.

Our board of directors includes members who spend many hours per week studying trends in manatee population, births, mortality and disease. That's why we weren't surprised when 3276 manatees were counted statewide in 2001, 40% more than the previous high count and six times the estimated population in 1972. In fact, we publicly predicted that record count months ahead of time and were asked by the Fish & Wildlife Conservation Commission how we could have known. We knew that the bitter cold that year would force most manatees to the warm water discharges, and the clear, calm weather would allow a good count. We studied the increases in natural manatee mortalities and other factors over the years and concluded a healthy population growth rate of over 5 percent. We also weren't surprised by the lower count in 2002, hampered by warmer weather, or the record counts on the east coast in 2003.

One of our associates studied the mystery of propeller wounds and derived a relationship between the spacing of those wounds and the sizes of boats that couldn't have caused them. He further refined his model to show which way the vessel was traveling with respect to the animal, and the approximate size of the propeller. Whale researchers in Europe and dugong researchers in Australia are now applying his findings to their own work.

In 2001, CFFW helped raise \$45,000 to fund a study of underwater boat noise by the worlds foremost expert in

manatee hearing, Dr. Edmund Gerstein. That study confirmed Dr. Gerstein's long-held belief that manatees are unable to hear slow-moving boats until they are dangerously close, but can hear fast-moving boats while they are still at enough distance to let them avoid the boat. The use of Dr. Gerstein's patented sound-producing device may one day make pervasive slow speed zones a thing of the past.

Also in 2001, five members of CFFW filed an administrative challenge to stop the massive new slow speed zones passed by the Florida Fish & Wildlife Commission. Joined by attorneys from Standing Watch, the city of Cocoa Beach, the city of Titusville, and Sea Ray Boats, we showed how the Commission failed to follow their own rules when creating the new zones. Shortly after losing that challenge, CFFW raised \$25,000 and hired a prestigious Tallahassee law firm to appeal the decision. Ultimately, the appellate court decided not to get involved in this contentious issue and issued a percuriam decision upholding the state's actions.

Many of our members and Board of Directors have served on various committees over the years, including the Brevard Marine Advisory Council, the Brevard Dredging Committee, The CM3P or Comprehensive Maritime Management Master Plan, the Manatee Forum, and so on.

CFFW is also urging the state to listen to sound science and follow where that science leads. We have worked many years cultivating a relationship with the various state agencies to ensure that the boater and waterfront property owner are represented and given a voice at the state level. CFFW has had a lobbyist in Tallahassee for several years working to represent our interests and advise us on any legislative issues that we should be aware of.

We continue to grow our club and work toward reasonable regulation of our waterways. We invite you to join our club, or just attend one of our monthly meetings. Visit cffw.org for more information. •

With E15...Boaters, Anglers Will Need Extra Vigilance When Filling Up at the Pump

Dump a Boat in the Lagoon, Go to Jail!

Sometimes it takes enforcement a long time to make it happen, but it's good when it happens!

In early February the Florida Fish & Wildlife Conservation Commission was successful in sending to jail a man who repeatedly put the environment and other boaters in jeopardy with his junk boat.

Jeremy Ross, 31 of Virginia was sent to jail for 39 days after a nine-month investigation into the ownership of a wrecked and grounded vessel in the Banana River, east of Snug Harbor, in Brevard County.

FWC Officer Jeff Luce recognized the vessel from back in 2008 when Ross was charged with having an abandoned, derelict vessel. At that time the charges were dropped, but Ross returned to his ways of causing a maritime nuisance with his junk boat, and this time the charges were prosecuted.

"Abandoned and derelict vessels can pose safety and navigational hazards as well as become eyesores in Florida's beautiful waterways," said Capt. Richard Moore of the FWC's Boating and Waterways Section.

Owners are responsible for removing derelict vessels at their own expense, or they risk criminal charges, potential loss of vehicle and vessel registration privileges, and being fined for both court costs and the cost of removing the vessel.

We're happy for this officer's tenaciousness in getting this guy (hopefully) off of Florida's waterways! Maybe he'll go back to Virginia! �

Several of the slides I presented showed all those zones in Central Brevard, and compared them to a "coincidence analysis" FWC has begun to use. Coincidence means waters where manatees and boats "coincide". The coincidence analysis, which was developed as a result of CFFW's lobbying, only considers two dimensions – surface area, but not water depth. Unfortunately, in black and white the slide included here won't mean much, but even this still-crude tool shows that a lot of Brevard regulations happen where manatees are not—and for that matter, vice versa.

How can speed zones that only "sorta" speak to where manatees and boats are found be effective? And what, exactly - or even "sorta" - is the goal of all those speed zones, whether effective or not? Is it to eliminate manatee mortality from boats? Reduce it? Keep it from increasing? What? No answer. No kidding, no answer. Previously, I had received a promise from FWC to convene a workshop at the Fish & Wildlife Research Institute to do with speed zone effectiveness what we did with forensic pathology – convincing FWC to make use of Jim Wood's groundbreaking method that uses propeller marks to assess the size of striking vessel. Even here, FWC argued with my factual statement that FWC now uses the method. Scott Calleson averred that FWC developed its own propeller mark assessment method, which is different from Wood's. Talk about missing the point! These are the very people who in 2002 flatly said no method would work!

At the Forum, they seemed to be waffling on their promise. At this point, we – CFFW – are supposed to give FWC a workshop program concept; they will then try to gather the right people to attend. Of course, all sorts of people with agendas beyond science will want to be included. My position – one I hope the Board and YOU will share – is we aren't doing anything at a workshop that doesn't stick to the science issues at stake: what can we do to clean up the mess we're in with speed zones; what can we do to establish meaningful, measurable standards for zone implementation and measurement, and how do we justify the cost of it all?

One aspect we didn't stress at the Forum was the incredible cost of speed zones – without any known gain. The truth is, I was armed for bear and had the stats to spell it out. Speed zones have been one of the worst

investments in "protection" ever. No kidding. Ever.It just struck me that we have a governor who wants to run government like a business, but we have a manatee protection program that's being run like a liberal arts college, with no real agenda and no real results, but a "tuition" bill that keeps going up.

Other News

On related news, the US FWS is moving ahead with its plan to downlist manatees to "threatened". They have their work plan in place to do this and say it will take two years. Because the state changed its imperiled species list, once the Feds do this, the state is supposed to follow along. Expect the "usual suspects" to throw a toolbox worth of monkey wrenches into this process.FWS also will have a bunch of new survival data and other stats over the next few months. While there are some old-hand CFFW folks who disdain this research, I am generally impressed with it. My expectation is we'll finally see the fast-rising number of perinatal (baby) deaths surfacing as an indicator there are too many manatees for habitat to support in many areas. The 'usual suspects' will spin such a finding to mean we must return even more water to manatee-only sanctuaries, to replace "habitat destroyed by human activity". Warm water will be the top priority for FWS. I spoke at length with FPL's representative at the Forum about the amazingly blind-eyed decision to heat the water at the old FPL plant site in Brevard during construction of the new plant. Unlike past discussions, where Bob Atkins and I were assured this decision was the result of long hours of inquiry by people a lot smarter than us, the FPL rep said it was an emergency situation where they had no time to consider other options. Business or liberal arts? You decide.

Speaking of YOU decide...I often rant about boaters who think they're on some kind of scholarship to CFFW. Every now and then I run across some boater who acts like \$25 is gonna kill 'em, but for the most part, I don't think it's the dues. I know a lot of people don't like to join groups because they figure they'll be hit up for volunteer time, more donations, etc. True enough, but CFFW is pretty relaxed about all that. Participate when you want, and hopefully have fun! We just plain need more boater members to get the job done! Urge your neighbors and relatives to join. See you at the Flea Market. ❖




