CFFW Marine Flea Market Event Rules and Regulations

The move-in date is limited to Friday only between the hours of 8am and 4pm. Please do not try to move into vendor spaces prior to Friday as they will not be available.

Pricing for 2023 is as follows:

20x20 interior space 2 days = \$300.00 20x20 perimeter space 2 days = \$350.00 12x12 interior space 2 days =\$200.00

\$50 discount on 20x20 spaces or \$25 discount on 12x12 spaces if paid before February 1, 2023.

There are a limited number of spaces that will allow on-site trailer parking. Your complete rig, including tongue and ramps will be required to fit within the allotted space that you rent.

You may need to purchase additional spaces to accommodate your vehicle, trailer and display. These are available on a *First-come*, *First-served* basis. The earlier we receive your payment and contract information, the better your chance of acquiring one of these spaces. It is very important that you contact us prior to sending in your contract to confirm availability for the space you require or if you are requesting a specific space.

The vendor spaces are protected and monitored overnight, Friday and Saturday from 6 pm-6 am.

NO VEHICLES WILL BE ALLOWED IN THE EVENT AREA WHEN IT IS OPEN TO THE PUBLIC; NO EXCEPTIONS. This is a safety issue and will be strictly enforced. If you park within your rented vendor space, you will not be able to enter or leave between the hours of 7 am and 5 pm both days.

This event is RAIN OR SHINE and will not be rescheduled due to inclement weather.

All vendors will provide a current fire extinguisher. **Required for all tents**.

The event and parking is free to the public.

Incentives are provided upon receipt of vendor space reservations and payments made before February 1, 2023. ALL cancellations will incur a \$50 processing fee. Cancellations after February 1, will result in a forfeiture of space fees.

No sales of food prepared-on-site are permitted. Sales of pre-packaged food items (honey, jerky, etc) will be evaluated upon request.

Vendors are responsible for cleanup of rented space. The space shall be returned to "broom clean" condition. Garbage receptacles are provided for this use. Cleanup includes removal of any and all articles placed in or on the ground (including waste products, merchandise and debris). Anyone not complying with this will incur additional cleaning fees and will not be invited back to this event.

Reserved vendor parking is marked and exists adjacent to the flea market vendor area.

Vendors will have **no generators**. No loud music, radios, stereos, TV, or loudspeakers. Be courteous to your neighbor and keep the volume down.

All flea market merchandise, vehicles and tent stakes must be within space assigned. All aisles must be kept open at all times for emergency vehicle access as required by the Fire Department. Offenders are subject to being removed from the Flea Market event and from future event registration.
