Making Gains with Deeper, Navigable Waters on the Intracoastal Waterway

Goal: Bring important marine highway back to its operational 12-foot depth

Waters have been getting deeper, improving navigation, safety and vessel access along the 1,100-plus-mile Atlantic Intracoastal Waterway since Congress began investing in the waterway as a continuous system across state boundaries and U.S. Army Corps of Engineers Districts. Before the waterway was recognized as Marine Highway 95 by the U.S. Department of Transportation, severe shoaling and thin waters in certain locations were threatening safe navigation and the passage of vessels.

Since 2016, the estimated \$120 million bill for dredging costs to return the waterway to

its originally authorized width and depth has been halved, with projects completed from New Jersey to Florida. More recently, the 2021 Bipartisan Infrastructure Law (BIL, formerly known as the Infrastructure Investment & Jobs Act) delivered \$20.25 million in additional funding for upland placement area maintenance in North Carolina. BIL will also fund an additional \$7.47 million in New Jersey dredging projects.

The job isn't done, however, and at the recent annual fly-in to meet with Congressional representatives, in Washington, D.C., Atlantic Intracoastal Waterway Association board

members (AIWA) stressed efforts needed to address the still-significant backlog of unmet dredging needs.

"AIWA's efforts showing the importance of continued commercial and recreational vessel activity along America's Marine Highway 95 is having an impact," said AIWA executive director Brad Pickel, "But there is still work to do."

More recent waterway funding projects have addressed the need for important maintenance on upland areas where dredge material is deposited. "Without these upland locations we cannot continue to dredge and keep the channel clear," said Pickel.

Joining AIWA in Capitol Hill legislator and staff discussions were representatives from

Boat Owners Association of The United States (BoatUS), National Marine Manufacturers Association, and other AIWA board members. BoatUS Government Affairs manager and AIWA board member David Kennedy added, "In the last 10 years, we have done a good job helping the U.S. Army Corps of Engineers identify unmet dredging needs. We want to ensure evolving trouble spots are also identified."

Pickel, Kennedy and other AIWA board members met with 12 congressional offices including Reps. Nancy Mace (SC), Jen Kiggans (VA), Buddy Carter (GA) and Greg Murphy, M.D. (NC). "We greatly appreciate these legislators who are looking out for the waterway," added Kennedy. •

On the Path to Balance Anchoring Rights, Is There Light Ahead?

BoatUS says Broward County, Fla., ordinance is a win for responsible boaters, communities

SPRINGFIELD, Va. Feb. 27, 2023 – Boat Owners Association of The United States (BoatUS) is applauding a recently passed Broward County, Florida, ordinance that, according to the recreational boating advocacy, services and safety group, could lead to a successful path ahead in fairly balancing the needs of both local

communities and responsible cruising-boat owner's rights when it comes to anchoring.

The ordinance revolves around two small manmade lakes in Hollywood, Florida, North and South lakes, each connected to the Intracoastal Waterway. Locals have long shared

the waters – North Lake was designated an idle-only area, drawing sailors and paddlers, while South Lake was used for powered-vessel water activities. For years, responsible long-distance cruisers were welcome in both anchorages.

A dramatic increase in abandoned derelict vessels (ADVs), at-risk or improperly long-term anchored boats over the past few years have changed that equation, however, crowding out all other activities with some vessel owners anchoring for months and even years. These vessels are often poorly maintained and their anchoring gear is prone to failure. Each storm only increases the number of safety hazards in the water and ashore. Many anchored boats don't meet U.S. Coast Guard safety regulations on required night time lighting or sanitation equipment. Irresponsible boaters have simply been squeezing out locals and responsible cruisers alike.

Approved last November, Broward County's ordinance tackles the issue directly, allowing for up to 45-days of anchoring for any vessel within any six-month period. It also adds an exemption for imminent or existing hazardous weather — increasing boater safety by not

requiring crews to haul anchor and head out into potentially unsafe weather conditions.

"We believe 45 days is a reasonable time frame for a vessel to remain in a particular area and will allow all active, responsible cruising and recreational boaters to use, anchor, rest, repair, visit, re-provision, and enjoy these bodies of water," said BoatUS Government Affairs manager David Kennedy.

Kennedy notes, however, that efforts to educate the public, including installation of local signage, updating of navigation aids as well as online cruising resources, and ultimately any enforcement activity could take some time before significant results are seen. "We'll be monitoring the situation closely," he said.

Since 2009, the Sunshine State has been at the center of the nation's stormy challenge in trying to balance the rights of responsible boaters and local communities when it enacted a state-wide bill to limit local governments from regulating anchoring. Don't Hit the Water This Summer Without a No-Cost, No-Penalty Vessel Safety Check4

Top 3 Reasons Why Boats Fail

How do you know your boat is ready for a safe summer boating season and complies with new U.S. Coast Guard regulations? A no-cost, no-penalty vessel safety check from the U.S. Coast Guard Auxiliary and U.S. Power Squadrons/America's Boating Club can help. Scheduled inspections are often offered at launch ramps, marinas and boat clubs, or appointments can be made for a vessel examiner to come to your boat. Go to cgaux.org/vsc to learn more. The program is sponsored by the BoatUS Foundation for Boating Safety and Clean Water.

Upon successful completion of the exam, which typically takes less than 30 minutes, the vessel is awarded a U.S. Coast Guard / Auxiliary / U.S. Power Squadrons decal that informs law enforcement and safety agencies that your boat was in full compliance with all federal and state boating laws during a safety check for that year.

So just what items do vessels typically fail on this important early season inspection? According to the U.S. Power Squadrons/America's Boating Club, the top three reasons are:

- 1. Navigation lights 19%
- 2. Fire extinguishers 18%
- 3. Distress signals 16%

"The numbers tell us a vessel safety check can help owners of every type of boat," said BoatUS Foundation assistant director of boating safety Ted Sensenbrenner. "Nearly as many 'open' type vessels (44%) fail vessel safety checks as much as those with enclosed cabins (47%). A vessel safety check on either type can help a bad day get a lot better, or potentially save a life."

Boat clubs, marinas, boat yards and municipalities with launch ramps are also encouraged to reach out to their local U.S. Coast Guard Auxiliary or U.S. Power Squadrons/America's Boating Club to schedule a vessel safety check day at their property.
